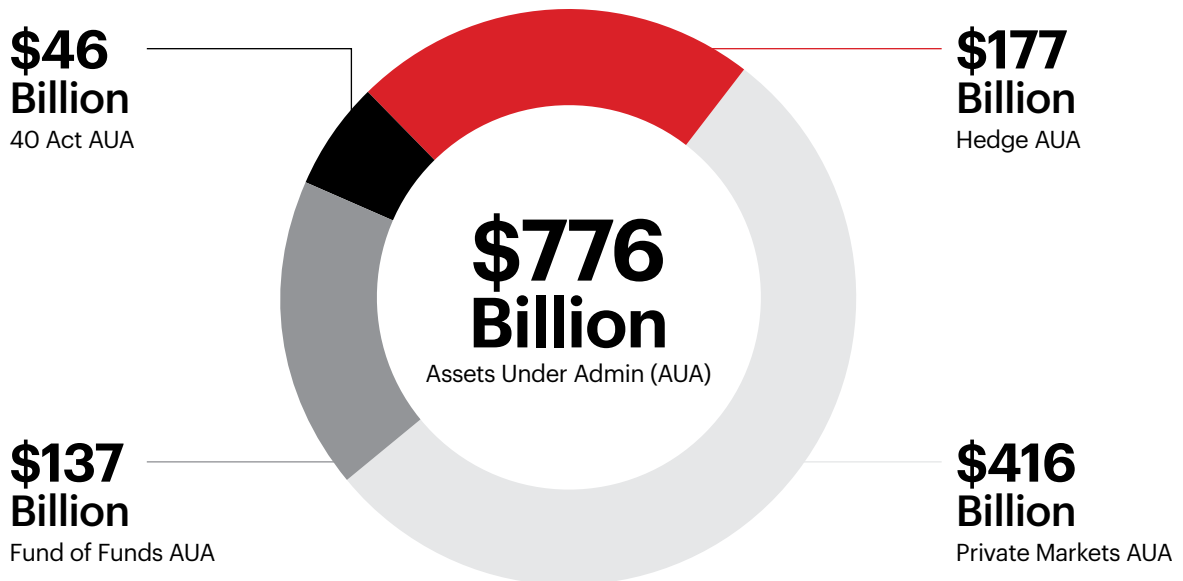

Numbers reflect asset classes serviced by all entities of MUFG Investor Services as of Q1 2023 in USD Billions

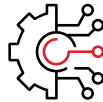
